TERMS OF SERVICE

This agreement documents the terms of service for web accounts provided by "Hosting Nation" Dba/ Hosting Nation Data Inc. (hereinafter 'Hosting Nation') to the account holder. This is the Terms of Service for all web sites operated by Hosting Nation Data Inc., administrator of Hosting Nation (www.hosting-nation.com) and TOTALSnap (www.totalsnap.ca). Use of a Hosting Nation account indicates acceptance of the terms of this agreement by the account holder. This agreement contains the full understanding of the parties with respect to the subject matter hereof. Any email correspondence with the account holder which is in any way inconsistent with, or which adds to, the provisions of this agreement is null and void.

ACCOUNT USAGE

Any use which interferes with the server's ability to function, including but not limited to its primary purpose of publishing web documents, is prohibited. Hosting Nation takes a zero tolerance approach to the sending of Unsolicited Commercial Email (UCE) or SPAM over our network. Very simply this means that customers of Hosting Nation may not use or permit others to use our network to transact in UCE. Customers of Hosting Nation may not host, or permit hosting of, sites or information that is advertised by UCE from other networks. Violations of this policy carry severe penalties, including termination of service. Violation of Hosting Nation's SPAM policy will result in severe penalties. Upon notification of an alleged violation of our SPAM policy, Hosting Nation will initiate an immediate investigation (within 48 hours of notification). During the investigation, Hosting Nation may restrict customer access to the network to prevent further violations. If a customer is found to be in violation of our SPAM policy, Hosting Nation may, at its sole discretion, restrict, suspend or terminate customer's account. Further, Hosting Nation reserves the right to pursue civil remedies for any costs associated with the investigation of a substantiated policy violation. Hosting Nation will notify law enforcement officials if the violation is believed to be a criminal offense. Please note that if you do any massmailing you MUST properly identify the source of the e-mail, additionally you MUST supply an easy and concise method for the recipient to remove themselves from your mailing lists. Any further contact between you and the person who requested removal will be considered SPAM and may result in termination of your hosting account. All mass-mailing lists you use MUST be opt-in only, you cannot use so called "targeted" e-mail services or e-mail CD services for mass-mailing purposes with our accounts. Use of the Hosting Nation facilities to provide software or lists for mass mailing unsolicited email is prohibited. Use of the Hosting Nation facilities to commit network abuse (including, but not limited to, denial of service (DOS) attacks including, but not limited to, ping bombing, email bombing,

"smurf", "winnuke", "land", "teardrop", etc.) or otherwise compromise the security of hosts or networks is prohibited. All data stored or transmitted must be legal under all applicable Canadian laws. The account holder is solely responsible for determining the legality of their data which is stored or transmitted. Hosting Nation assumes no liability for any and all data stored or transmitted by any account holder. Should the account holder become the target of a network attack, Hosting Nation reserves the right to take any and all necessary actions (including, but not limited to, temporary suspension of the account holder's account) required to return server or network operation to normal. While Hosting Nation employs its best efforts to maintain the integrity of data and communications including, but not limited to, email, network use, and the contents of user directories, Hosting Nation makes no assurances, guarantees, or warranties with regard to the privacy of any and all aforementioned information and communications. Hosting Nation invoices account holders monthly or annually for hosting and annually only for domains. Invoices are automatically sent out 15 days previous to the due date and payment is required on or before the due date. Overdue accounts may be terminated or suspended at Hosting Nation's sole discretion. Hosting Nation reserves the right, at its sole discretion, to issue special invoices when the balance due will be more than \$100 (Canadian funds) over the base monthly service fee. A late payment fee will be assessed on all accounts at a rate of 24% per annum (2% monthly). Hosting Nation may terminate service to the subscriber at any time, without notice, for violation of this agreement. Hosting Nation is not responsible or liable for any damages or harm to the account holder resulting from such termination. The account holder may terminate their account at any time by notifying Hosting Nation via email to info@hosting-nation.net, or by postal mail to Hosting Nation Data Inc., #10 - 1176 Franklin's Gull Road, Parksville, BC. CANCELLATIONS & REFUNDS

If you cancel your account or services prior to the end of the initial term or the renewal term, whichever is applicable, Hosting Nation shall not refund any fees paid in advance of such termination. For account cancellation requests indicating the account is to be cancelled at the end of the term, the client shall retain full rights to the account until the current billing term is concluded. On the first day following the expired term, the account shall be terminated. It is the responsibility of the client to ensure that all data and e-mail is downloaded prior to such time, as once the account is cancelled all data is automatically erased, and the account can not be reopened without renewing for an additional term. All cancellation requests will be processed within 14 days, so if you wish to discontinue services with Hosting Nation please provide a minimum of 14 days notice to ensure that your account does not incur charges into the next billing period. Clients who choose to have their account cancelled immediately will lose access to all data and e-mail as soon as the virtual authorization is received or on the day the postal mail cancellation request is received. It is essential that the client has downloaded all e-mail and data prior to such request, as once the request is processed, the data is erased immediately and the account can only be reopened by renewing the account for an additional term. Hosting Nation may terminate this Agreement at any time and for any reason by providing to you written notice of termination. If Hosting Nation terminates this Agreement, Hosting Nation shall decide at its sole discretion if a refund is applicable unless otherwise expressly provided herein. At the discretion of the client, any remaining time in a cancelled hosting account can be donated to Hosting Nation for the explicit use of providing free hosting services to various non-profit organizations. If you wish to donate the remaining time in your hosting account, please send a cancellation request along with permission to transfer your remaining hosted services to info@hosting-nation.net indicating you wish to donate to a non-profit organization of our choice.

RESELLER/PARTNER CLAUSE

Hosting Nation reserves the right to suspend services or bill clients directly in the case of unresolved outstanding payments by it's authorized active resellers and partners.

LIABILITY

Your use of our Internet sites or any of the information, links, products or services offered on those sites (collectively, the "Services") is subject to these Terms of Use (these "Terms"). "Hosting Nation", at its sole discretion, may change the Terms, conditions and operation of this website (www.hostingnation.com) at anytime without notice to you. TERMS & CONDITIONS OF HOSTING TRANSFERS

When you transfer your hosting to Hosting Nation Data Inc., Hosting Nation Data Inc. will credit your account with the remainder of time left on your hosting package to a maximum of one year. Credits are added to the end of your first year's hosting with Hosting Nation. You must purchase one year of hosting to be eligible for a credit. Credits may not be redeemed for cash or a rebate. To receive a credit for hosting, you must provide proof of expiration date in writing. Acceptable documents include invoices or any official documentation from your current webhost indicating the expiration of your current hosting account.
